Preamble

All students seeking to undertake studies at Perth Bible College are required to complete an application for course enrolment and supply all the required supplementary materials. The admission requirements must be met for the duration of a student's enrolment. Should an application be found to have been approved on the basis of fraudulent information or materials, the enrolment would be cancelled immediately. Should an application be found to have contained misleading information or non-disclosed information relevant to the admission criteria the student's enrolment would be reviewed, revised, or cancelled as deemed appropriate.

1. Australian Students

- 1.1. An Australian Student is either a citizen of Australia or a Permanent Resident of Australia (including Permanent Humanitarian Visa holders).

2. Overseas Students

- 2.1. An "Overseas Student" is a non-resident who has applied to study at Perth Bible College in Australia and who requires a "Student Visa" from the Australian Government in order to study.

3. International Students (non-student visa students)

- 3.1. An "International Student" is a non-resident of Australia who has entered Australia on any other visa that permits Part Time or Full-Time study to be undertaken at Perth Bible College. The study permitted is dependant on the stipulations of the applicant's particular visa.

4. Equality of access

- 4.1. Perth Bible College does not discriminate in the admission to any of its programmes and activities on the basis of disability, age, gender, marital status, pregnancy, political conviction, race, colour, national or ethnic origin or denominational affiliation.

5. Application Process

- 5.1. All Applications should be addressed to the Dean of Students.
- 5.2. Applicants may attend the college to discuss the application process with the Dean of Students:
 - 5.2.1. This face to face discussion is primarily for the benefit of the student, to provide information about the courses, the contents of units, the requirements of the study programmes, and to enable them to become familiar with the facilities and procedures of the college.
 - 5.2.2. Selection criteria may be discussed and clarified during the discussion but no new selection criteria are included.
- 5.3. The Dean of Students will assess each application to ensure that all relevant materials have been received. Required materials are outlined in the Australian Student Prospectus and the Overseas Student Prospectus.
- 5.4. PBC will reply to the applicant advising that the application and specified fees have been received.
- 5.5. The Dean of Students will then send a request for referral and a PBC referral form to the applicants nominated referees.
- 5.6. Once all required documents are received and all applications fees are paid the application will be processed.

- 5.7. Applicants that meet the above requirements are then interviewed (if possible) by the Dean of Students.
 - 5.7.1. The Interview: An interview is only undertaken if a face to face discussion is geographically possible. The interview is primarily for the benefit of the student, to provide information about the courses, the contents of units, the requirements of the study programmes, and to enable them to become familiar with the facilities and procedures of the college.
 - 5.7.2. Selection criteria may be discussed and clarified during the interview but no new selection criteria are included for discussion at the interviews.
- 5.8. The application is then either approved or declined by the Dean of Students in consultation with one other faculty member, preferably the College Principal or the Academic Dean in line with the requirements for entry criteria.
- 5.9. Students will be notified of the approval or declination decisions, with the reason for declination stipulated, within 14 days of receipt of a completed application. All students will also be sent a formal "Letter of Offer".
- 5.10. All students will then be required to complete and return the "Acceptance of Offer" (included with the "Letter of Offer" along with all required fees before a "Conformation of Acceptance" and "Overseas Student Confirmation of Enrolment" (CoE), which shows that PBC has notified the Australian Authorities that the applicant has been accepted to a particular study program, will be issued.
- 5.11. Should an applicant be dissatisfied with the determination of their course enrolment application the applicant may apply to have the decision reviewed by following the processes outlined in P22 Grievance Policy.

6. Requirements for Entry

6.1. Academic Requirements

Students will be required to demonstrate that they are able to meet the academic requirements as outlined below for each course application.

¹ *Provisional Entry Admission*

A student may be granted entry into any course on the basis of Provisional Entry if they are able to demonstrate a reasonable likelihood for satisfactory completion of the course requirements. Students admitted by Provisional Entry have a Course Status of Provisional Standing (see P21 Academic Progress). It is compulsory for a provisional student to complete a Study Ready unit (Effective Academic Communication; Semester 1 and Theological Thinking and Writing; Semester 2) prior to, or in conjunction with their first year of study. Should your application be successful, all your obligations as a provisional entry student will be outlined in your formal "Letter of Offer" (see 5.10 above).

Prospective students seeking admission via the Provisional Entry pathway should submit a portfolio containing the following:

- a) The PBC Application Form
- b) A cover letter outlining your motivation and reasons for seeking entry. The letter should reflect commitment, preparation and commitment to successfully complete the course.
- c) A Resume outlining your work and/or ministry experience, both paid and volunteer, that supports your application.
- d) Academic Records for any and all education and training to date. This includes workplace or ministry training and courses.

Prospective students applying for Provisional Entry will be required to complete an interview as outlined in section 5.7 above.

Under section 6.8 above, in the case of a Provisional Application, after the interview, the Dean of Students will make their informed judgement on the demonstrated reasonable likelihood for satisfactory completion of the course, and outline the reasons for this decision and any further conditions on the entry (e.g. any compulsory support services). The decision will then be reviewed by the Academic Dean or the Principal prior to being finalised.

In the case of provisional entry students, the prior experience reviewed would not qualify for Recognised Prior Learning credit as the prospective student's inability to enter the course via a direct pathway provides no grounds for demonstrating achieved outcomes at the level or rigour of the course.

6.2. Personal and Spiritual Requirements

Students will be required to meet the following criteria:

- 1. Confess faith in Christ in accordance with the PBC Statement of Faith.
- 2. Be involved regularly in a local church.
- 3. Express a desire to be involved in Christian ministry.
- 4. Have a capacity for studying in a tertiary institution.
- 5. Agree to abide by PBC policies, procedures and Code of Conduct.

- 6.3. Overseas Students must be 18 years of age to be permitted entry into a PBC course.
- 6.4. Domestic students must be 17 years of age if they have not completed Year 12 to be permitted entry into a PBC course.
- 6.5. Should there be any concern regarding the student's ability to complete any course, in addition to the admission requirements of this policy, the College may require an applicant to demonstrate fitness for admission as a candidate by meeting such medical requirements, carrying out such extra academic work, and/or sitting such examinations or tests as the College may determine.
